

# Application for Early Move-in for the Fall Semester

■ This notice is about early move-in of accepted residents. Accepted residents (selected applicants) who want to move in earlier than officially move-in period should apply the application.

■ Resident must read the notice thoroughly, and will be held responsible for everything resulting from not having done so.

## 1. Early Move-in for fall semester

- A. Early move-in opening date: August 30th(Sun.) 12:00 ~ December 13th(Sun.) 12:00 [106 days]  
[Myungyui-gwan] August 30th(Sun.) 12:00 ~ January 17th(Sun.) 12:00 [141 days]
- B. Qualification: Accepted residents who can submit the early move-in confirmation for the fall semester.
- C. Room assignment: August 28th(Fri.) 22:00 YES 통합정보시스템
- D. Cafeteria:
  - Munhwa-gwan: September 20<sup>th</sup>(Sun.) Dinner ~ December 12<sup>th</sup>(Sat.) Lunch
  - Cheomsung·Nuri-gwan: September 20<sup>th</sup>(Sun.) Dinner ~ December 13<sup>th</sup>(Sun.) Breakfast

## 2. Apply

- C. Application period: Current ~ August 27<sup>th</sup>(Thu.) 15:00 \* No extension for application period
- D. Attention
  - 1) Those who do not apply for early move-in within the period can't move in early.
  - 2) Please write accurate information when applying.
  - 3) The requested information cannot be changed, so please fill it out carefully.
  - 4) Applicants for early move-in must apply carefully (whether they actually move in or not) because they cannot refund the dormitory expenses due to delayed opening.
  - 5) Even if you apply for early move-in, you cannot move in if the documents are incomplete.

## 3. 2020 fall semester Early Move-in Process

- A. Move-in period: August 30<sup>th</sup>(Sun.) 12:00 ~ 18:00, August 31<sup>st</sup>(Mon.) ~ September 1<sup>st</sup>(Tue.) 09:00 ~ 18:00
  - \* If you are unable to move in within the move-in period, you must submit "statement of reason for delayed move-in" in advance to the dormitory email. Refer to the website of the dormitory for the relevant forms.
- C. Check the room number: August 28<sup>th</sup> 22:00 (Scheduled) at YES통합정보시스템
- D. Required Documents: Those who fail to submit documents are not allowed to move in without exception

※ Those who have applied for early move-in among the current residents should submit required documents to the R. A. office assigned to the fall semester by August 29th (Sat.)

- 1) Chest X-ray examination report 1(check for tuberculosis)
    - Validity of Chest X-ray: Within 2 months of move-in date(2020. 8. 30.)
    - Original copy and it should be in only Korean or English.
  - 2) Health declaration form, Residence consent form
    - Refer to the website of the dormitory for the relevant forms. [Download] dorm.knu.ac.kr→생활관생→신청양식
  - 3) Passport(or immigration certificate)
    - Those who enter the Korea less than 15 days from abroad cannot move in
  - 4) COVID-19 Test Confirmation: If you are the current resident in dorm, you don't need to do that.
    - If your current resident registration is Seoul or Gyeonggi-do, Incheon, you should do the COVID-19 test confirmation. Students in Seoul, Incheon and Gyeonggi Province must submit COVID-19 test confirmation (results) to move in. The examination is free of charge at Buk-gu Health Center in Daegu. After the examination, it is issued by the health center (a reservation for the examination must be made in advance). ☎ Buk-gu Health Center 053-665-3211
  - 5) Early move-in confirmation(department or professor or office of international affair)
- E. Move-in procedure: If you do not wear a mask, you are not allowed to enter the dormitory.
1. Hwamok(화목)·Munhak(면학) Residents: Assigned dormitory 1F

- Measure body temperature ▶ Submit the required documents ▶ Register hand vascular pattern ▶ Move- in
2. **Myungyui(명익) Residents:** Move in procedures at the B1F and submit the required documents
- Measure body temperature ▶ Submit the required documents ▶ get the key ▶ Move- in
  - ※ Unable to move in if the body temperature is greater than 37.5 degrees Celsius.

- F. Refund standard: In case of halfway move-out, will be calculated on starting and leaving date.
1. Room(Maintenance Fee): After 3/4 of semester after opening date, you cannot receive refund.
  2. Meal: Before 15 days of the end of the semester, you cannot receive refund.

## 8. Important Notes

- A. Dormitory residents must be comply with the dormitory regulations and living rules of KNU dormitory.
- B. Residents must comply with quarantine measures within the period of residence, personal quarantine rules (wearing a mask, washing hands, keeping distance, etc.), temperature check (once a day, three times warning and then expulsion), and the prohibition of staying out overnight(2 times warning and then expulsion) etc.
- C. If additional documents are required to be submitted after moving into the dormitory, residents should cooperate with it.
- D. No access to other dormitory and rooms.
- E. You should leave dormitory if you leave of absence or graduate from KNU. If you don't, you will be expelled from the dormitory.
- F. The KNU dormitory administration office is not responsible for cancellation due to incorrect contact information(such as E-mail address and phone number). So you should change your information in YES 통합정보시스템
- G. We have a small delivery storage room, so please receive your packages personally after you move into dormitory.
- H. There may be restrictions on the use of public facilities. e.g.) Fitness room, reading room, PC room, etc.
- I. COVID-19 and other circumstances may result in adjustment of the opening schedule (e.g. postponement, extension, reduction, etc.) or change of dormitory or room at any time, and the residents must cooperate with the plan.
- J. All required documents should be in Korean or English.
- K. If any required documents are found to be false or counterfeit, your application will be canceled.
